

PayedNow API Integration Process





At the time of deposit or withdrawal, PayedNow verifies player identity and transaction source through real-time KYC checks, ensuring compliance with AML requirements.


3. PP Authorization & Encryption:

Payments are processed immediately or scheduled based on player preferences, enhancing the overall user experience.


